General Data Protection Regulations 2018 (GDPR) PRIVACY NOTICE

1. INTRODUCTION

- 1.1. The Utility Gundog Society is committed to protecting your personal information and respecting your privacy
- 1.2. This Privacy Notice sets out the basis on which any personal data that we collect from or about you, or that you provide to us, will be processed by us.
- 1.3. For the purposes of the General Data Protection Regulations (GDPR), the individual responsible for data issues within each Utility Gundog Society Branch is the Branch Membership Secretary.
- 1.4. We may update this Privacy Notice from time to time. Please check back regularly to see any updates or changes to this Notice.

2. DATA PROTECTION CONTACT

- 2.1. The contact details for the Branch Membership Secretary for any data protection queries are available on the branch website.

3. DATA PROTECTION PRINCIPLES

- 3.1. We will comply with data protection law. This says that the personal information we hold about you must be:
 - 3.1.1. Used lawfully, fairly and in a transparent way.
 - 3.1.2. Collected only for valid purposes that we have clearly explained to you and not used in any way that is incompatible with those purposes.
 - 3.1.3. Relevant to the purpose we have told you about and limited only to those purposes.
 - 3.1.4. Accurate and kept up to date.
 - 3.1.5. Kept only as long as necessary for the purposes we have told you about.
 - 3.1.6. Kept securely.

4. PARTICULARS OF PROCESSING

- 4.1. We process personal data about members and competitors to our events. The categories of person about whom we process personal data are described in more detail in the annex to the Privacy Notice.

5. YOUR RIGHTS AS A DATA SUBJECT

- 5.1. The General Data Protection Regulation provides the following rights (subject to some exemptions)
 - 5.1.1. The right to request access to personal data that we hold about you;
 - 5.1.2. The right to request rectification of the personal data that we hold about you;
 - 5.1.3. The right to request erasure of the personal data we hold about you;
 - 5.1.4. The right to request restriction of the processing about you;
 - 5.1.5. The right to object to processing; and
 - 5.1.6. The right to data portability.
- 5.2. If you wish to raise a complaint on how we handled your personal data, you can contact the Branch Membership Secretary.
- 5.3. If you are not satisfied with our response or believe we are processing your personal data not in accordance with the law, you can complain to the Information Commissioners Office (ICO) full contact details for which can be found at <https://ico.org.uk/global/contact-us/>

6. HOW WE USE INFORMATION ABOUT YOU

- 6.1. We will generally process your personal data for contractual necessity in providing membership services and events.
- 6.2. We may also use personal information for additional relevant and related purposes where you might reasonably expect us to do so, where the benefits for doing so are not outweighed by your own personal interests or fundamental right or freedoms.
- 6.3. This may include:
 - 6.3.1. To maintain our records and other administrative purposes, including updating your details and preferences
 - 6.3.2. To assist with queries, complaints and dispute resolution.
 - 6.3.3. For communications related to membership.
 - 6.3.4. To assist with upholding our club constitution and taking action in cases where there may be a breach of the Society rules of Codes of Ethics.
- 6.4. We do not use personal data for any marketing purposes.
- 6.5. You have the right to lodge a complaint with the supervisory authority. In the United Kingdom, the supervisory authority is the ICO.

7. RECIPIENTS OF DATA

- 7.1. We may use service providers to help us provide you with our services. Personal data may be transferred to such service providers who act for and on our behalf, for further processing in accordance with the purpose(s) for which data was originally collected or may otherwise be lawfully processed.
- 7.2. Such third parties have contracted with us as data processors under the requirements in GDPR. They are contractually bound to only use personal data for the agreed purpose(s). Relevant persons working for these third parties will have access to your personal data under the terms of the data processor contract, but only to the extent necessary to perform their services for us.
- 7.3. The data processors agree to implement reasonable contractual and technical protections, to keep your data confidential, not sell your personal data to third parties, and to not disclose your personal data to third parties except as required by law, as permitted by us or as stated in this Privacy Notice.
- 7.4. In appropriate circumstances we may disclose to authorised bodies as required by law.

8. VISITORS TO THE UGS WEBSITE

- 8.1. We do not use cookies to monitor how people use our website.
- 8.2. By registering for any online service, you automatically accept our terms and conditions.

10. ANNEX

This Annex sets out the Utility Gundog Society's processing of personal data relating to members (including Committee Members) and competitors at our events.

10.1. What personal data do we process, why do we process it and what is the lawful basis?

10.1.1. **Members** - Name, Address, Email Address, Telephone number(s)

We process your personal data for the following purposes:

Contractual Necessity

- 10.1.1.1. Provision of membership services including administration and transactional communications relating to membership.
- 10.1.1.2. Upholding Society Rules and Code of Ethics
- 10.1.1.3. Compliance with Kennel Club Rules and Regulations.

Legitimate Interest

- 10.1.1.4. Contacting you regarding information about society events and meetings.

Consent

- 10.1.1.5. Contacting you by email to provide related information.
- 10.1.1.6. Publication in the society year book.

10.1.2. **Judges** – Refer to the Kennel Club website for Judges Details.

10.1.3. **Competitors** – Name, Address, Email Address, Telephone number(s), Dog information

We process your personal data for the following purposes:

Contractual Necessity

- 10.1.3.1. Administration and transactional communications for competitors entering events.
- 10.1.3.2. Provision of services relating to our events.
- 10.1.3.3. Upholding Society Rules and Code of Ethics
- 10.1.3.4. Compliance with Kennel Club Rules and Regulations.

Legitimate Interest

- 10.1.3.5. Contacting you regarding future events
- 10.1.3.6. Publication of dog's details in the event schedule (subject to the right to object)
- 10.1.3.7. Publication of event result son our website and yearbook. (names and dog information only)

We also process personal data for the Society's legitimate interests as we have outlined in the main Privacy Notice. Please be assured that we will always take account of your personal data rights in doing so.

10.2. Where do we obtain your personal data from?

Most of the above personal data is received direct from you (the data subject) when applying for membership, when entering Working Test and Field Trials or applying for special Training Days. However, information may be received from third parties (e.g. The Kennel Club and their list of Official Panel of Field Trial Judges and FTMS).

10.3. How long do we hold your personal data for?

Personal data will be retained in accordance with the statutory requirements, Kennel Club requirements & recommendations and the Society's Retention Policy which is 12 months from the date that membership lapsed. Complaint and Discipline Records will be retained for a period of five years.

10.4. Are you obliged to provide us with your personal data?

You are not obliged to provide the personal data in question. However, if you do not provide the personal data we will be unable to perform any contract we have with you for the provision of membership service, judging appointments or event services.

10.5. Kennel Club records

The Kennel Club will hold personal data of Officers of The Utility Gundog Society as part of the implementation of Kennel Club Rules & Regulations.

We provide the Kennel Club with details of Utility Gundog Society officers and award winners at our events to meet requirements of the Kennel Club Rules & Regulations.
